No.R.S. 18/8/1/2018/17-Perl. - Consequent upon conclusion of the disciplinary proceeding initiated against Shri Urujul Hasan, Deputy Director (Security) (under suspension) on the charges of sharing several offensive, derogatory, demeaning and sarcastic posts on social media against the Hon'ble Prime Minister of India and some Union Ministers and Chief Ministers as also sharing a number of posts indicating his active involvement/assistance/indulgence in political activities, canvassing in connection with an election to the legislature, failure to maintain political neutrality etc., and thereby violating Rules 3(1)(iii), 5(1), 5(4) and 3(1)(vii) of the CCS (Conduct) Rules, 1964, the Disciplinary Authority, Hon'ble Chairman, Rajya Sabha has, in pursuance of Rule 14 of the Rajya Sabha Secretariat (Recruitment and Conditions of Service) Rules, 1957 read with Rule 11 of the CCS (CCA) Rules 1965, imposed the penalty of 'reduction to the lower grade of Security Officer for a period of five years' on Shri Urujul Hasan, Deputy Director (Security) (under suspension) with directions that the period of reduction shall operate to postpone future increments of his pay falling due in this period and on expiry of the said period, he shall not regain his original seniority in the grade of Deputy Director (Security), *vide* his Order dated 10.02.2020.

2. Accordingly, penalty of 'reduction to the lower grade of Security Officer for a period of five years' stands imposed on Shri Urujul Hasan, Deputy Director (Security) (under suspension) with effect from 10.02.2020 with directions that the period of reduction shall operate to postpone future increments of his pay falling due in this period and on expiry of the said period, he shall not regain his original seniority in the grade of Deputy Director (Security).


